Annual Congregational Meeting January 29, 2023

An opening prayer was offered by Pastor.

Katrina Hinesley addressed the group regarding God's blessings and the call to come to the meeting with God in mind. She urged attendees to recognize that we are a body of Christ and to treat each other as members of the church family using compassion, empathy, encouragement and kindness.

She quoted scripture from Philippians and emphasized that even with money matters trusting in the Lord is important. She concluded by saying that God's not done here, so let's base our decisions on the trust in God.

Call to order—President Kevin Rahn called the meeting to order at 11:47 a.m.

A total of 31 voting members were in attendance.

Establish Agenda—The agenda was accepted as distributed. Kevin pointed out the numerous reports contained in the Annual Report and encouraged attendees to read the reports.

Approval of 2021 Congregational Meeting Minutes from January 30, 2022—A brief discussion was conducted regarding last year's meeting and the minutes. Motion: Accept the minutes of the January 30, 2022 congregational meeting after striking the phrase The Jensen Memorial from the sentence on page 6 reading "The Jensen Memorial and B Street Property Fund could be used to supplement other than giving." Motion by: Ryan Hinesley. Second by: Phyllis Ogden. With a show of hands, the motion carried.

Approval of Semi-Annual Congregational Meeting Minutes from June 5, 2022--Motion: Accept the minutes of the June 5, 2022 semi-annual congregational meeting. Motion by: Joel Anderson. Second by: Earl Small. With a show of hands, the motion carried.

Elections—President Rahn indicated that according to the proposed constitution, elections must be done by written ballot. He read the list of nominees for election for the coming year as follows: **Church Council**—Amy Agren, Jon Davidson and Curtis Thomsen;

Frantzvog Estate Fund Committee—Paul Schwinn;

Nominating Committee – Tiffany Seidl and Geri Skreen;

Synod Delegates—David Whittaker, Jacki Whittaker

President Rahn called for nominations from the floor for council or any open position. None were presented. **Motion:** Close nominations for 2023 annual meeting and proceed with voting. **Motion by:** Julie Davidson. **Second by:** Paul Schwinn. President Rahn thanked the members of the nominating committee. By written ballot, all nominees were elected with 30 "yes" and 0 "no."

Consideration of the 2023 St. Paul Lutheran Constitution—President Rahn reminded the congregation that the church has been operating under a 2018 constitution with a few exceptions. He explained the synod has come up with revisions for constitution. Much of the constitution is required language however, notable changes to the locally-controlled items include the following:

- Incorporates the Terms of service and term limits as approved by the congregation Sept. 12, 2021;
- Allows the congregation council to enter into contracts of up to \$8,000 (previously \$5,000) for items not included in the budget;
- Authorizes the council to spend up to 10% of the annual budget if an unforeseen, but necessary, expense arises that is not contained within the budget without a congregational meeting/congregational approval;

- Removes the exclusion of council members or their spouses from serving on the Staff Support Committee;
- Increases the number of congregation members required to propose a constitutional amendment from one to 10.

A recent revision was sent to all members maintaining a Youth Representative position on the council although the youth group has been inactive and has not put forward a name. Also, the model constitution included language that the serving pastor would vote on the council, however, after much discussion, that section was not updated in the presented draft to the congregation to reflect the model.

He said the procedures, if the constitution is approved by the congregation is that it will be sent to the synod for approval and congregational ratification would be required at a semi-annual meeting.

A request was made to have printed copies made available.

Responding to a question, it was clarified that all council members are elected for two years, but a few members are completing their third year having been elected under the old constitution.

Motion: Approve the St. Paul Lutheran Church Constitution as presented in the updates. Motion by: Curtis Thomsen Second by: Earl Small . By written ballot, the constitutional revisions were approved with 28 "yes" and 0 "no."

Consideration of Proposed 2023 Spending Guide—President Rahn pointed out to the congregation that as of Dec. 31, 2022, the church's actual to spending guide was -\$18,540.64. For clarification purposes, there are specific accounts (such as Jensen and Emerson) that are sources of funds to reimburse the general fund and total of \$9,650.26 was transferred from other accounts to cover appropriate costs. A total of \$8,890.38 was used from the Payroll Protection Program Grant to cover the overall deficit. The ending balance of the PPP Grant is \$12,709.62.

He also reviewed that coming out of COVID, Lent service was resumed resulting in additional compensation for the organist; conversations arose concerning the organist as an independent contractor vs a church employee. In looking at the requirements, it was decided that starting in 2023, the organist would be considered an employee. The feeling was that the IRS would consider him an employee in the event of an audit, and we would be responsible for back taxes payroll. Another factor in increased costs is the leased copy machine, and in September, we started paying for the pastor's health insurance.

On the positive side, the rent obtained from the preschool and the adjacent property is slightly higher for 2023. In sources of income, envelope and loose giving are down slightly.

A big thanks to Treasurer Leann Beall was extended for all her hard work to provide accountability and information to the congregation.

President Rahn indicated that 8-10% inflation has been a killer in the past several months—most families and businesses have experienced this. An example is the increase in gas prices 28%. However, unlike a business we cannot increase our prices.

Thanks was extended to Property and Finance for the draft spending guide document that was approved with only minor changes by the church council. Other Jensen will be spent on capital improvements to our church.

Richard Skreen provided an update from Property and Finance regarding possible uses of the Jensen Fund for landscaping/grass on the south property, improvements to the fenced area on the east side of the church, and a waterproofing system on the sanctuary walls. He reported that Jensen Fund monies will be adequate to meet those needs. He reported that Property and Finance is formulating a 5 to 10-year capital improvement schedule. Included in that will need to be the \$65,000 expected cost to re-roof the sanctuary within 5 years. Beyond 5 years that cost is expected to raise 3-4% for every year past year 5. Property and Finance will ask the council to consider restricting use of the B Street Funds for a capital reserve for the roof. The Bjorhus property reroofing cost would be \$6,000 in today's dollars.

Katrina Hinesley asked people to consider long-term plans and if the building looks good, but if no one is in the building. She stressed the importance of letting God move. She added it is time to consider how to invest in ways in addition to the facility. Richard indicated that the Property and Finance Committee's charge is to keep the congregation informed of the physical needs of the facility.

Venita Thomsen asked if we find ways to have income by charging small fees for use of the building and the community needs to know that this space is available. Richard indicated that the format is in place to do that, but it has not been promoted. A member of the Grange indicated that the Grange building is not being requested either.

President Rahn indicated that very few changes were incorporated in this year's spending guide but Cocoa and Crafts was a new outreach. It includes 5% of envelope and loose offerings for synod support.

In People resources he highlighted a 4% pay increase for Geri and Ruth. Pastor Norm's 5% salary increase varies from the 10% increase indicated by the Synod's 2023 compensation guidelines. This is a difference of \$3,437 less than the salary guidelines. When council approved the spending guide it was agreed that we would revisit the church's finance in June with the thought of reassessing the compensation.

A reallocation of pastor's compensation moved a portion from housing into salary as a lateral move. Pastor explained that this will impact his Social Security benefits in the future. President Rahn reminded the group that starting this year we will pay the full year of medical insurance. Payroll taxes reflect the addition of the organist to employees.

Discussion ensued regarding restricting B Street Funds for the roof. Also, a question arose about selling the Bjhorus property as an income source. Earl responded that while it has been discussed, the property has been fairly low impact. It could be considered in the future. The rental property has been used to house an intern, and if we got an intern in the future, we would need to find housing for the intern.

It was stated that the church has "been in the rental business for the past 40 years." The rental property revenues go into the general fund as an on-going revenue stream. It was asked if the B Street fund is restricted, where would money to cover a general fund shortfall come from? Jackie Schwinn stressed that initial conversations regarding the proceeds from the B Street sale indicated that it would be for long-term maintenance needs.

President Kevin indicated that the 2023 Spending Guide proposal of \$225,722.76 which reflects approximately a \$24,000 increase in expenses. The deficit was \$8,890.38 in 2022 which would result in an approximate \$33,000 deficit for this spending guide. Some PPP money remains, but not to fully cover the deficit. If the B Street Fund cannot be used, President Rahn asked where the money would come from. This equates to 15% difference in the expenses to income and President Rahn provided some examples of 15% increase in giving for various giving levels.

Curtis Thomsen suggested the congregation explore a Habitat for humanity partnership for the new roof project and the physical properties. The congregation was reminded that the Mission Builders were responsible for supporting the fellowship hall construction.

Mary Rosen reassured the congregation that God's going to make this work and we should give God room and let God work.

Julie Davidson expressed thanks for Kevin's leadership. It was followed by a round of applause.

Motion: Adopt the 2023 Spending Guide as presented. Motion by: Phyllis Ogden: Second by: Venita Thomsen. The motion was approved by written ballot 25 "yes," 4 "no."

Additional Questions and/or Comments—On behalf of the congregation, Tiffany offered thanks to President Rahn for serving with his kind and steady leadership to the community of St. Paul.

Neil Agren stated that as a 44-year member he wanted to pose the question "where are we going as a church?". He expressed sadness that at his age, he is a "young" member. He challenged the attendees to think of the community and bring folks to GAP and have them understand that this is a welcoming place. He said to pray for this church that we can minister to younger people.

Venita Thomsen talked about the importance of getting youth involved.

Pastor Norm said sometimes he feels he is not listened to. He offered the following comments

- look around and see you are dying.
- you have a tremendous facility.
- if you are expecting me to save this church it is not going to happen. God is going to save this church.
- regardless of how old we are, we can pray for the future of St. Paul.
- if you don't know what your story is, ask God.
- as Lutheran we have to get more comfortable with introducing people to God.
- young people aren't the saviors of this church either -- they are people of God.
- at least three people have to greet newcomers to make them feel welcome.
- God Loves you.
- How do you want to die? If it's not you that is going to revitalize the church, if it is "what can the church give to me?" then this church will die.
- Please consider what you want the future of this church to be.

Benediction—Pastor Norm offered a closing benediction.

A Letter From Our Pastor

This past year, 2023, began with continued efforts to work collaboratively with other Lower Columbia Conference churches. We continued to have a Men's Wednesday morning Zoom study and prayer. We had a Chili Cookoff, where St. Paul won the competition bringing home the grand prize of best chili.

Following the season after Epiphany we celebrated Shrove Tuesday which hadn't been done in my tenure. It was great to gather as a community and provided me with a sense that we were continuing to move beyond Covid and returning to normal. Following the pancake feed, we began the Lenten season with Ash Wednesday. We had our Wednesday Lenten Plays and singing of Holden Evening Prayer through Lent.

Our contemporary music band (G3) added a new member, and we began to practice anticipating beginning Contemporary Worship in the Fall. In March we went to \$5 Movie Night at the Regal and viewed "Jesus Revolution." We have done \$5 Movie Night several times since. It is a "cheap date" and a way to see a new release inexpensively while having some fellowship outside of church.

G3 has played at our God's Abundant Plate (GAP) meals monthly for a few years now. GAP continues to grow in attendance each year. This year there were 594 meals served over eleven months. Amy Agren has done a fantastic job of heading up this ministry of fellowship serving those inside and outside the church.

At holy week we celebrated Palm Sunday, Maundy Thursday, Good Friday with Crosswalk and "Christ's Seven Last Sayings." Several of us participated in the annual Ecumenical Easter Sunrise Worship. This was followed by Easter Breakfast and Worship at St. Paul.

Later in April, eight members of St. Paul were trained in Godly Play story telling. This is another program that was started in the Fall. Leann Beall has taken a leadership role in this ministry and with the help of those who were trained has drawn more youth and, in some cases, their parents to church. This was always the hope. It isn't a quick fix, but a wonderful, Spirit filled, ministry that engages young people through the telling of Bible stories.

In May, we had a special worship titled "Experiencing God." Also, in May, my Dad died and I went to his funeral prior to going on Vacation to Ireland for a couple weeks in June. In July several of our members participated in the CR Fair Parade, handing out candy and advertising Godly Play. Leann and I drove to Vancouver to see how an established Godly Play room was set up. Leann then took the lead and ordered materials for Godly Play, Prepared the Godly Play room, and began to coordinate scheduling of classes. This was a great undertaking and is very much appreciated.

In August we had a Joint Outdoor Worship at my house with Gloria Dei, Kelso members. This was the third year we have participated in an outside worship, and it is a great time of fellowship and coming together with our sisters and brothers at Gloria Dei. August was also a lot of planning for the Christian Education that begins in September and the second annual Oktoberfest. St. Paul also saw Sandy Catt and Diana Rahn graduate from the two-year Path for Strengthening Active Lay Ministry (PSALM) program. A huge shoutout to both graduates for undertaking PSALM, then having the discipline and commitment to finish it. It is a great accomplishment.

Oktoberfest had to be rescheduled and was cold and wet with our scheduled band not showing. G3 stepped in and played and we set up a sound system to play Oompa music. There were some lessons learned. It was great to have a large tent to congregate under and there were many who helped this outreach to be successful.

The Godly Play program began in September, Dan Shero began teaching a study on Job, and a monthly Contemporary Worship was started. Thank you to all who participated and took on leadership roles in these programs.

At the end of October, we participated in the Conference wide Reformation Worship at Trinity and again had Trunk n Treat in front of the church, but we also participated in the CR event handing out candy and flyers for Godly Play. Thank you, Curtis for the help at the CR event and all others who participated in Trunk n Treat at the church. "It takes a village" and there were many who were in both the Reformation Worship and Trunk n Treat. Thank you!

November saw the end of another church year and December the start of a new one. St. Paul provided cocoa and crafts during the Festival of Lights and then hosted the after party. We had a second annual Blue Christmas/Longest Night service where 25 people participated. This was a very meaningful worship to me, and I am very appreciative to all who helped. The last Sunday in December we participated in a joint worship with the Methodist where the CR Men's Ensemble led us in worship.

Other ministries that occurred through the year were Men's Prayer Breakfast, Pastries with Pastor, Taco Tuesday at the Pastime, Thirsty Thursday fellowship at rotating venue, and Hineni Prayer on Thursday mornings, Community House Meals in LV, Walden Island Tea and I am sure there were more.

Overall, I think we had a very busy and productive year where we saw numbers going up, though not to pre-pandemic levels. This happens only with the help of some amazing people.

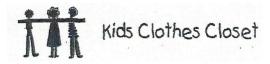
Kids Meals

For the 23rd year, St. Paul has organized and hosted the Kids Meals program, which provides free lunches during the summer months to any child who wishes to attend. In addition to St. Paul, the following congregations participated in providing food and serving lunches: Castle Rock Christian, Apostolic Lutheran Church, St. Mary's Catholic Church, Church of Jesus Christ of Latter-Day Saints, Castle Rock First Baptist Church, and Castle Rock Methodist Church.

Clarance Knutson supervised and organized the nine-week program. St. Paul was responsible for two weeks of meals this year. Thank you to KC Babcock for your leadership with one week of this year's meals. KC's crew: Kathleen Duysen, Beverly Foul, Sharon Blankenship, Lynne Donahe, Anita Gallow, Philip Portwood, Jerry Borgaard, Cheryll Borgaard. Clarance's helpers: Pat Dick, Anita Gallow, Sharon Blankenship, Cheryll Borgaard, Jacki Whittaker, Becky Dahlman, Shirley Johnson, Neal Johnson, Mary Rosen, Loren Rosen, Jon Davidson, Paul Schwinn, and David Whittaker.

Expenses: custodial \$500, Dairy Fresh Farms \$634.94, kitchen supplies and food purchases \$2,696.67. We served 2,408 lunches to children and the needy in our community over the 8½ week period. An average of 58 kid's meals were served each day, an increase over the meals served last year. St. Paul's Kids Meals is funded by the Emerson Trust. Additional community donations of over \$1,000 was also received.

Kids Clothes Closet began the year with a winter shoe card give-away Feb. 25, 2023. Shoe gift cards were given to 68 children representing 23 families. We were also able to supply several students with gently used coats.

The 34th annual KCC summer give-away was held August 18. Packages of underwear and socks, and gifts cards for jeans and shoes were given to 146 children, preschool through high school, an increase over last year's attendance. A good selection of used clothing was available for tops and pants.

Many thanks to Curtis Thomsen and Leona Boone for sorting donated clothing. Also, thanks to Geri Skreen for preparing and mailing reminder postcards and to Dayne Johnston for writing donation thank you notes.

KCC received \$3,801 in donations this year with the Walden Island tea responsible for \$3,241 of the total. We thank KC Babcock for her hard work with the tea as well as all our loyal supporters who contributed.

With the increase in attendance at the closet over the last two years, expenses are up. For the first time, it was necessary to transfer \$4,000 from savings. Socks and underwear were purchased in the amount of \$1,865.35 from Target, Walmart, and Penneys. To try to hold down costs, socks and underwear are purchased in bulk whenever possible and repackaged for distribution. Also purchased were shoe gift cards for older students from Big 5, \$3,482; cards for jeans and younger student shoes from Walmart, \$5,475; a few shirts from Goodwill, \$28.53; stamps for reminder postcards, \$70.20; and ziplock bags for underwear, \$38.64, for a total of \$10,959.72 in expenses. KCC ends the year with \$6,021.38 in checking and \$7,794.02 in savings.

KCC is grateful for donations of new and/or gently used children's clothing, sizes 4T to teen. We ask that adult size clothing be suitable for high school students. Volunteers are needed for all aspects of the closet carried on in preparation for the summer giveaway.

The Kids Clothes Closet is a much-needed service to the community. It is shown in the faces of grateful parents and the children who are so excited over a new package of socks.

Parish Education

Parish Education looks at ways we might promote Christian Education, Bible Study, and God for the benefit of our faith community. There is an Adult Sunday School class that occurs every Sunday throughout the school year. There are opportunities for men provided through a monthly Men's Saturday Breakfast and a Conference Zoom Bible Study/Prayer that met each Wednesday morning through the spring. In addition, the Women regularly meet for a Bible Study each Wednesday evening. A Texts Study (Pastries with Pastor) occurs each Wednesday morning throughout the year.

Adult Sunday School offered an Old Testament/Hebrew Scriptures survey course study in the spring and a study on Job this fall. They regularly have 8-12 people attend.

The conference study had 5 members of 3 different congregations attending regularly, but wasn't restarted after the summer break.

Men's Saturday Breakfast has 5-8 attendees regularly.

The Women's Wednesday Study has 10-15 attendees regularly.

Pastries with Pastor has 5-7 people attending weekly.

Godly Play training was attended by Monte Hartshorn, Leann Beall, Kevin and Diana Rahn, Randy White, Jon Davidson, Sandy Catt, Amy Agren and me. The training provided attendees with storytelling techniques used in the program. The Godly Play program is geared towards youth. Leann Beall has taken the lead in coordinating the program. It has been successful through her leadership and the volunteers actions. The numbers of youth attending has steadily, though slowly, increased through the fall season. I expect it will continue through the winter and spring providing a wonderful opportunity for growth both spiritually and in our numbers.

Hineni Prayer meets every Thursday morning for a time of listening to God. Three members meet weekly.

Property and Finance

As we do each year, Property and Finance keeps a watchful eye on how we spend our money as well as how the economy and our church giving will impact the budget. Most of our time and meetings October through December are spent working on the proposed spending guide in order to have it ready for the council to approve or to make adjustments as they see necessary.

This year our committee continued the building and site projects, some funded by the Jensen gift:

- 1. A new lighting control system to the Sanctuary was developed by Paul Schwinn, Earl Small, and Jim Johnston, including a new switch control panel and converting pendant lighting to LED lamps for energy efficiency and ease of operation.
- 2. This year the water line double check valve (backflow prevention) failed its annual test; Sessions Plumbing was hired to replace the unit and retest to verify proper function.
- 3. The kitchen refrigerator unit required replacement of a failed compressor.
- 4. Work on the yard and landscape was performed adding to the landscape in front of the building and reseeding a new lawn in front of the Fellowship Hall. A new sprinkler system was also added.
- 5. David Whittaker assisted in keeping the boiler and furnaces in good working condition. We are working to establish proper procedures for control of thermostats throughout the building for comfort and energy efficiency.

Looking forward to 2024 we will continue project work including:

- 1. Work on the old fenced playground outside the East Room of the church building by installing a new paver system for ease of maintenance and for use as an outdoor patio area.
- 2. Replace the existing in-floor mounted grease separator in the kitchen with a new unit.
- 3. Plant grass at the rental house in the fall.
- 4. Require by end of school year in June that preschool clean up and remove all unused items in former Prayer room on second floor and large storage room on third floor. (Current situation would not be acceptable under house cleaning provision of Church Mutual Ins. Co.) Make appropriate changes to a 2024 preschool lease agreement.

A huge shoutout to Earl Small for his diligent attention to the church building and grounds as he (almost daily) checks in and tends to many behind the scene maintenance tasks.
